In the identified area, the current year population is 159,115. In 2010, the Census count in the area was 138,942. The rate of change since 2010 was 1.48% annually. The five-year projection for the population in the area is 168,729 representing a change of 1.18% annually from 2019 to 2024. Currently, the population is 48.3% male and 51.7% female.

The median age in this area is 28.7, compared to U.S. median age of 38.5.

Current per capita income is \$18,220 in the area, compared to the U.S. per capita income of \$33,028. The per capita income is projected to be \$20,822 in five years, compared to \$36,530 for all U.S. households

Currently, 69.2% of the 48,641 housing units in the area are owner occupied; 25.1%, renter occupied; and 5.7% are vacant. Currently, in the U.S., 56.4% of the housing units in the area are owner occupied; 32.4% are renter occupied; and 11.2% are vacant. In 2010, there were 41,543 housing units in the area - 72.4% owner occupied, 23.5% renter occupied, and 4.1% vacant. The annual rate of change in housing units since 2010 is 7.26%. Median home value in the area is \$137,778, compared to a median home value of \$234,154 for the U.S. In five years, median value is projected to change by 2.41% annually to \$155,186.
